The validity of this information is limited to the sites listed and not for other third-party websites that may be consulted by the user through hypertext links related to external resources.

Specific information as integration may be made available on individual websites, where required.

THE DATA CONTROLLER

Following the consultation of this site, data relating to identified or identifiable persons may be processed.

PURPOSE OF PROCESSING - LEGAL BASIS OF PROCESSING

The personal data processed during the consultation of the portal are aimed at allowing navigation and are processed by the University of Pavia in the performance of its tasks of public interest and related to institutional purposes (art. 6, paragraph 1, lett. e) of Regulation (UE) 2016/679), for institutional communication activities aimed at giving knowledge and visibility to institutional activities pursuant to Law n. 150/2000, to obtain anonymous statistical information on the use of

the University's official portal or related services, to fulfil legal obligations, comply with orders from public authorities, ascertain any liability in case of hypothetical cybercrimes against the site or its users.

The legal basis for the processing of cookies or other tracking tools is to be found in the consent referred to in art. 6, paragraph 1, lett. a) of Regulation (EU) 2016/679.

TYPES OF PROCESSED DATA

Browsing data

The computer systems and software procedures responsible for the operation of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. These data are necessary for the use of web services. This category of data includes the IP addresses or domain names of the computers used by users connecting to the site, the addresses in URI (Uniform Resource Identifier) notation of the required resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (success, error, etc.) and other parameters related to the operating system and the computer environment of the user.

The data are automatically deleted (except for any need for detection of crimes by the judicial authority).

Data provided voluntarily by the user

For the use of online services, which require authentication and registration, personal data provided voluntarily by users are used.

The optional, explicit and voluntary sending of e-mail to the addresses indicated on this site involves the subsequent acquisition of the sender's address, necessary to respond to requests, in addition to any other personal data entered in the communication.

Specific information is published on the pages of the University's websites designed to provide certain services.

OPTIONAL SUPPLY OF DATA

The user is free to provide the personal data requested in the online services forms. Failure to provide them can involve the impossibility to fulfill the request.

COOKIES

Cookies are small strings of text that a site sends to the user's browser (for example, Internet Explorer, Mozilla Firefox or Google Chrome), which stores them and then retransmits them to the same site at the following visit of the same user.

The Google Analytics service of the company Google, Inc is being deactivated on all the peripheral sites referred to in letter b) with active IP address masking, to allow anonymization of all IP addresses of users. IP masking or anonymization occurs as soon as the data is received by the Google Analytics collection network, before any storage or processing takes place to generate usage statistics.

The processing related to the services of the University portal will be handled exclusively by the staff and collaborators of the University at the University sites or by companies expressly appointed as data processors, who carry out their activities within the purposes set out in the respective contracts and through staff identified and explicitly appointed.

In such circumstances, the data may be processed at the premises of the service providers. Personal data may be communicated, in the cases provided for by Community provisions, laws or regulations.

PROCESSING METHODS

Personal data are processed with automated tools for the time strictly necessary to achieve the purposes for which they were collected.

Specific security measures are observed to prevent data loss, unlawful or incorrect use and unauthorized access.

RIGHTS OF THE DATA SUBJECTS

Data subjects have the right to ask the Data Controller for access to personal data and the rectification or cancellation of the same or the limitation of the processing concerning them or to oppose the processing (art. 15 and following of Regulation UE 679/2016). The request is submitted by writing to the University of Pavia, C.so Strada Nuova n. 65, 27100 Pavia, certified email: amministrazione-centrale@certunipv.it or via the DPO. The interested parties, based on proved conditions, also have the right to complain to the Guarantor according to the procedures provided for by art. 77 of Regulation UE 679/2016, or to act according to art. 79 of Regulation.

How to disable cookies

You can refuse consent for the use of cookies through the banner that appears on the first access to the site.

You can change your cookie preferences at any time by clicking on the "Cookie settings" link in the footer of the portal.

You can also withdraw your consent to the use of cookies by selecting the appropriate setting on your browser.

However, if you revoke your consent to the use of all cookies, you will not be able to use the services that require authentication.

Delete cookies already stored on the terminal

Even if the authorization to the use of third-party cookies is revoked, cookies may have been stored on the user's terminal before such revocation.

The user's browser allows their deletion in the privacy settings. The browser options contain the option "Clear browsing data" which can be used to delete cookies, site data and plug-ins.
